6. The committee

6.1 ...

6.2 Appointment

- a. The committee shall be comprised of, but not limited to a chairperson known as the president, a secretary and a treasurer.
- b. A committee member shall be a natural adult person, and a financial member of the Association.
- c. All committee positions shall be subject to re-election at each AGM.
- d. A retiring committee member shall be eligible to stand for re-election without nomination. No other person shall be eligible to stand for election unless member of the Association has nominated that person preferably at least 28 7 days before the meeting by delivering the nomination of that person to the secretary of the Association. The nomination shall be signed by the nominator and by the nominee.
- e. Notice of all persons seeking election to the committee shall be given to all members of the Association with the notice calling the meeting at which the election is to take place.
- e. Both the nominator and the nominee must be current financial members of the Association.
- f. The committee may appoint a person to fill a casual vacancy, and such a committee member shall hold office until the next annual general meeting of the Association and shall be eligible for election to the committee without nomination.
